On Friday, May 5th, more than 200 friends of ETM took over the legendary Four Seasons Restaurant in New York City to celebrate ETM's 15th Anniversary. ETM Board member Andrew Malik and Liz Smith-Malik were Benefit Co-Chairs, and Four Seasons' Managing Owner Julian Niccolini and his wife Lisa were Honorary Chairs. The event raised over \$195,000 for ETM's programming in disadvantaged schools.

After an opening cocktail reception and Silent Auction in the Grill Room, guests moved into the Pool Room for dinner, which was filled for the occasion with cherry blossom trees and rose petals. ETM Executive Director Katherine Damkohler welcomed the crowd and introduced the Event Chairs and Honorary Chairs, and presented them with gifts as a token of ETM's thanks for their help with the Benefit.

Ms. Damkohler went on to introduce students from three East Harlem partner schools, along with their teaching artists. Children from Mt. Carmel-Holy Rosary and St. Ann's performed violin together for two selections: "Perpetual Motion", and "Blue Danube Waltz", and the P.S. 102 Honors Chorus treated guests to "What a Wonderful World", and "Blue Skies". Next up, Teaching Artist Jennifer Greene wowed the crowd by singing "Quando m'en vo" from "La Boheme".

After the performances, ETM Co-Founder Eldon Mayer reaffirmed ETM's commitment to its students: "[ETM] is all about the kids. I hope





ETM Spearheads Integration in St. Louis

On June 1st, Field Supervisor Chris Marolf led a full-day professional development seminar in St. Louis, MO, focusing on how academic teachers could better incorporate dance, theater, music, and visual arts into their language arts classes.

Academic teachers from Holy Trinity School in St. Louis, MO, and Sister Thea Bowman School in East St. Louis, IL, especially enjoyed the

seminar's lively discussion and focus on creative solutions. One academic teacher said: "The open environment allowed for discussion which will lead to thought and help me plan and focus in the future."

These schools began adapting ETM's model for their students in 1999 and 2004, with ETM providing professional development and consulting.

Evaluation Reveals Parents' Praise

As part of the ongoing external evaluation of ETM's programs, funded by the U.S. Department of Education, Philliber Research Associates (PRA) recently collected surveys from partner school parents. These surveys - in addition to feedback and data from and about students, administrators, and teachers inform PRA on the impact of ETM's programs in a variety of areas, including student achievement and changes in schools and communities.

Results from the first year of evaluation activities (2004-05) indicate that ETM supports positive student outcomes in music, self-confidence, and skills for learning. We will share results from the second year as they become available.

Below is a sample of what parents had to say about ETM.

"I am so grateful to have my son in this school and experiencing the joy of music. I hope the funding continues. My son has found an interest in an instrument he would have otherwise not learned."

"ETM has helped to open [my son's] ability to communicate more openly and be more expressive."

"I feel if [my daughter] can learn to play violin which takes patience and ability to focus, she can learn, adapt to anything."

ETM Gets A Makeover

Made possible through a service grant from the Taproot Foundation, ETM's new brochure debuted in April. Last fall and winter, a group of Taproot volunteers with expertise in design, marketing and writing worked with ETM staff to create a document that brings ETM's mission to life.

Ten O'Clock Classics **Provides Free Music** Lessons

In March, ETM began partnering with Ten O'Clock Classics (TOC) to bring free, private after-school music instruction to select students at P.S. 68 in the Bronx.

TOC makes classical music available to a broader audience by having classical musicians perform at non-traditional venues. As part of their education initiative, TOC provides free, weekly private music instruction and instruments to New York City students.

Jessie Reagen, a former ETM teaching artist at P.S. 68, was instrumental in helping TOC and ETM form their partnership. "While teaching at P.S. 68 I was frustrated that there seemed to be no place to refer the students for lessons if they were interested," Ms. Reagen said, lamenting that for students at P.S. 68 "traveling to Manhattan [for music instruction] might as well have been like going to another state."

To address this problem, Ms. Reagen put TOC's Founder Ronen Segev in touch with ETM Director of Programs Stephen Herx, Field Supervisor Chris Marolf, and the Principal of P.S. 68, Cheryl Coles. After making students' parents aware of the value of TOC's programs, children received instruments and began after-school instruction. This spring, Teaching Artist Jody Redhage and TOC musician Earl Mannien tutored seven students in piano, violin, and cello once a week at P.S. 68.



On Wednesday, May 31st, Emmy-winning reporter Morry Alter visited ETM partner school P.S. 69 in the Bronx to profile ETM's music programs for WCBS-TV. Until its partnership with ETM began two years ago, P.S. 69 was failing on all levels and in danger of being taken over by the state. The school now boasts among the highest standardized test scores in the city, an improvement that Principal Alan Cohen directly attributes to ETM's involvement with the school.

ETM invited Mr. Alter to visit third-grade, kindergarten, and Honors Chorus classes, and to speak to teachers, students, and parents about the importance of music class in the school.
